BUKIT MERTAJAM: Jabatan Perkhidmatan Veterinar (JPV) Pulau Pinang membuka kertas siasatan berhubung kejadian seekor kucing tergantung di belakang kenderaan pacuan empat roda (4X4) di Jalan Merak Jaya 5, Simpang Ampat, di sini, pagi semalam.

Pengarahnya, Dr Saira Banu Mohamed Rejab, berkata pihaknya sudah mengambil keterangan suspek lelaki berusia 30-an yang terbabit dalam insiden berkenaan.

Katanya, kucing terbabit kini di

bawah jagaan JPV manakala kenderaan pacuan empat roda yang digunakan semasa kejadian sudah disita.

"JPV mengesahkan sudah menerima aduan secara rasmi berhubung kes ini. Susulan itu, kita membuat pemeriksaan di lokasi pada hari sama kejadian, kira-kira jam 12 tengahari.

"Bertindak atas maklumat yang diterima, kita berjaya mengesan suspek dalam kes ini dan sudah mengambil keterangannya.

"Kertas siasatan dibuka mengikut Perenggan 29(1)(a) Akta Kebajikan Haiwan 2015 (Akta 772) yang sekiranya didapati bersalah boleh didenda tidak kurang daripada RM20,000 dan tidak lebih daripada tiga tahun atau kedua-duanya," katanya pada sidang media di Ibu Pejabat DVS Pulau Pinang di Bukit Tengah, di sini, hari ini.

Jelasnya, kertas siasatan yang lengkap nanti akan dirujuk ke pejabat Timbalan Pendakwa Raya dalam masa terdekat untuk mendapatkan arahan selanjutnya.

"Kita menasihatkan mana-mana orang atau persatuan berkaitan haiwan untuk menyalurkan terus aduan berhubung kebajikan dan penganiayaan terhadap binatang kepada JPV melalui pautan awa.dvs.gov.my (My Animal Welfare) dan tidak mengambil sebarang tindakan sendiri yang boleh mengganggu siasatan.

"Dalam kes ini, walaupun niat suspek adalah untuk membawa kucing itu ke klinik haiwan namun cara yang salah dengan tidak meletakkan dalam tempat khas telah membahayakan nyawa kucing terbabit.

"Pada ketika ini, keadaan kucing itu yang diselamatkan pihak kita berada dalam keadaan sihat dan stabil,"

katanya.

Terdahulu, tular gambar kucing yang tergantung di belakang pacuan empat roda sehingga mendatangkan kemarahan masyarakat khususnya pencinta haiwan.

Susulan itu, Persatuan Haiwan Malaysia menggesa JPV meneruskan siasatan terhadap insiden yang berlaku.

Presiden Persatuan Haiwan Malaysia, Arie Dwi Andika dilaporkan berkata, ia demi menegakkan sistem keadilan jenayah haiwan dan sebagai satu pelajaran supaya pemilik berhati-hati dalam mengurus dan mengendalikan haiwan bawah tanggungjawab mereka.-[BHONLINE](#)

BUKIT MERTAJAM, 9 Ogos- Seekor kucing yang tular dalam keadaan terjerut pada leher dan tergantung pada belakang sebuah pacuan empat roda kini dalam jagaan pihak Jabatan Perkhidmatan Veterinar (JPV) Pulau Pinang.

Pengarahnya, Dr Saira Banu Mohamed Rejab berkata, haiwan itu juga telah diberi rawatan.

Selain itu, keterangan suspek lelaki berusia 30-an telah diambil dan kenderaan yang digunakan dalam kejadian

tersebut juga ditahan untuk siasatan lanjut.

"Susulan aduan berkenaan, JPV membuat satu pemeriksaan awal di lokasi kejadian pada hari sama iaitu pada 8 Ogos (semalam) kira-kira pukul 12.00 tengah hari.

"Bertindak atas maklumat yang diterima JPV berjaya mengesan suspek dalam kes ini.

"Tindakan mengambil milik kucing telah dilakukan bagi tujuan siasatan dan

pemeriksaan lanjut serta rawatan oleh pegawai veterinar.

"Kucing itu kini berada di bawah jagaan JPV dan telah diberi rawatan yang sesuai," katanya pada sidang media di Ibu Pejabat JPVPP di sini hari ini.

Saira berkata, kertas siasatan dibuka di bawah perenggan 29(1)(a) Akta Kebajikan Haiwan 2015 (Akta 722), sekiranya didapati bersalah boleh didenda tidak kurang RM20,000 dan tidak lebih daripada RM100,000 atau dipenjarakan selama tempoh tidak lebih daripada tiga tahun atau kedua-duanya.

Kertas siasatan akan dirujuk ke pejabat Timbalan Pendakwa Raya dalam masa terdekat untuk mendapatkan arahan selanjutnya.

“Sehubungan itu, kita harap orang ramai tidak manipulasikan kes viral yang boleh menyebabkan kekeliruan selain disarankan mendapatkan maklumat daripada sumber sah,” katanya.

Police Receive Report on Cat Dragged by 4WD, JPV Opnes IP

NIBONG TEBAL, Aug 9 (Bernama) -- The police confirmed receiving a report over a video showing a cat being dragged by its neck and hanging from the back of a four-wheel-drive (4WD) vehicle at Jalan Merak 5, Simpang Ampat, here yesterday.

Seberang Perai Selatan (SPS) District Police Chief Supt Chong Boo Khim said the police received the report at 5.29 pm yesterday.

He said that based on a preliminary investigation, the 4WD driver, who is a local man, was not aware of the incident.

"He had found the cat and then took the animal to a (veterinary) clinic to neuter it and while on the way to the clinic, did not notice the cat, which was placed in the back of the vehicle had tried to jump out and got itself strangled," he said in a statement today.

He said the man only realised the cat was dragged by the neck after arriving at the clinic.

Chong said the case had been referred to the Penang Veterinary Services Department (JPV) for further action.

He also advised the public not to manipulate viral cases as it could confuse others.

Meanwhile, Penang JPV director Dr Saira Banu Mohamed Rejab said the department had recorded the statement of the 4WD driver, who is in his 30s.

We have also opened an investigation paper and the case is investigated under section 29(1) (a) of the Animal Welfare Act 2015, she said.-

Viral Stray Cat Hung By Neck From Pick-up Truck Survives

BUTTERWORTH: The Penang Veterinary Services Department (DVS) has opened an investigation paper on an alleged act of cruelty against a cat seen hanging from a vehicle.

Its director Dr Saira Banu Mohamed Rejab said the case is being probed under Paragraph 29(1)(a) of the Animal Welfare Act 2015.

"The investigation paper will be referred to the DPP for further instructions soon," she said in a statement on Friday (Aug 9).

Dr Saira Banu said the department had also recorded a statement from the subject of the investigation, a man in his 30s who was driving the vehicle.

She said the department received a complaint about the alleged incident that occurred at Jalan Merak Jaya 5, Simpang Ampat, Tambun at about 11.30am on Thursday (Aug 8).

"Acting on the information received, we successfully identified the person involved in this case," she said, adding

that the cat is now stable and under the department's care.

She added that the vehicle involved had also been temporarily confiscated for investigation.

It was reported earlier that a man found a stray cat in poor health near his home on Thursday and decided to take it to a veterinary clinic in Simpang Ampat.

According to South Seberang Prai OCPD Supt Chong Boo Khim, the cat tried to escape and ended up entangled and dangling from the vehicle.

He added that the man, who was accused of animal abuse after news of the incident spread on social media, then lodged a police report.-

BUKIT MERTAJAM: The cat seen in a viral picture with a rope tied around its neck and hanging from the rear of a four-wheel vehicle is doing well.

Penang Veterinary Services Department director Dr Saira Banu Mohamed Rejab said the cat had been treated.

"Our officers gave the cat an injection and it is doing well. Just some minor bruises.

"The cat will remain under our care," she said at the state DVS office in Bukit Tengah, near here, today.

She showed newsmen a photo of the cat, saying that she could not bring the feline out so as not to stress it.

A picture of the cat hanging from a vehicle had gone viral, sparking outrage among netizens.

Dr Saira Banu said the department had recorded statements from a man, in his 30s, who was driving the four-wheel vehicle and the vehicle's owner.

The vehicle had been seized for investigation.

Penang DVS opened an investigation paper into the case under Paragraph 29(1)(a) of the Animal Welfare Act 2015.

Dr Saira Banu said the suspect who drove the four-wheel drive claimed he was taking the stray cat to the vet for treatment.

She said he claimed to have placed the cat under a basket at the back of the vehicle.

She said he claimed that the basket flew off, causing the cat to fall off with a rope tied around its neck.

"Another driver followed the four-wheel drive to alert him to what happened.

"The way he handled the cat was not right. It should have been placed inside a carrier inside the vehicle," Dr Saira Banu said.-NST
